What Makes TMRS Great?


Members,

Investment Update

In January, Dave Hunter joined TMRS as Chief Investment Officer. Mr. Hunter has extensive finance and investment management experience, most recently managing a more than \$20 billion investment portfolio as the Executive Director and CIO of the North Dakota Retirement and Investment Office.

TMRS' 2021 net investment return was 12.8%, which exceeded our 6.75% assumed return. Trust Fund investments reached an all-time high of \$38.5 billion. More TMRS investment information is included in the 2021 Annual Comprehensive Financial Report, which can be found under the "For Cities" tab on tmrs.com.

In May, the Board selected NEPC as its General Investment Consultant to provide advice to the Board on all investment-related matters.

TMRS is proud to report that we can claim compliance with the Global Investment Performance Standards (GIPS®) and that the Trust Fund was examined, and the organization has been verified for 2021. A copy of the 2021 GIPS Asset Owner report can be obtained by emailing invrisk@tmrs.com. ★

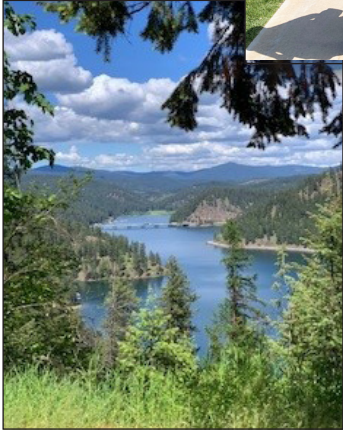
RV Dreams: TMRS Retiree Pamela Morgan

Sign Up for MyTMRS

You can access your TMRS account at any time using MyTMRS, located at tmrs.com. If you haven't registered, now is the time.

On MyTMRS you can:

- ▶ Print your confirmation letter
- ▶ Update your direct deposit information
- ▶ Make changes to your IRS form W-4P
- ▶ Update your contact information
- ▶ Review and update your beneficiary designation (if applicable)
- ▶ Manage your communication preferences

Managing your communication preferences allows you to choose email notification for annual statements and newsletters.

In October of 2021, TMRS also launched the TMRS mobile app. You can now log into MyTMRS from anywhere using your smartphone. To join the more than 16,000 Members who have already downloaded the TMRS app, use the QR code to the right. ★
