Your Account Information

Time Credit for Prior Public Service

Your city may provide time credit for prior public employment. Time credit can help you reach your city's TMRS vesting and retirement eligibility requirements sooner.

There are two categories of time credit that your city may offer:

1. Restricted Prior Service Credit. Restricted Prior Service Credit provides time credit for your active-duty military service or previous full-time employment with any U.S. public employer, including federal, state, county or city. There is no limit on the amount of time credit you can be granted.

To apply, complete the Application for Restricted Prior Service Credit available under the "For Members" section at tmrs.com.

2. Military Service Credit. Military Service Credit grants you time credit for prior active-duty military service. The maximum time credit you can receive is five years. **Note: You can also use Restricted Prior Service Credit for Military Service.**

To apply, complete the Application for Military Service Credit (Time Only) available under the "For Members" section at tmrs.com.

It May Be Better To Retire than Refund

If you are thinking about refunding your account, it's important to understand how it affects the funds you may receive in the long term.

If you refund your TMRS account balance, the refund will not include any city matching funds, and you forfeit the opportunity to receive a lifetime retirement benefit from this account.

If you are vested and leave city employment, you can leave your contributions in your TMRS account, and those contributions will continue to earn 5% interest every year until you retire. Once you meet retirement eligibility, you can receive a lifetime retirement benefit that includes the city matching funds.

If you are not vested, you can leave your contributions in your TMRS account for up to five years, and your account balance will continue to earn 5% interest each year.


Members at Work

So, in late July, after breaking her femur in seven places, taking a day off was the farthest thing from her mind. She explained it simply, by saying, "I couldn't sit there and dwell on it." Instead, she did what she always did and went to work.

For three weeks, surrounded by stacks of paper, her laptop, and a printer, she made certain that the 400 residents of Milano were taken care of. And they, in turn, made sure that Carolyn had everything she needed once she was able to leave the hospital. They brought her food and water and took her wherever she needed to go. It's clear that Carolyn's dedication and love for her city is recognized and appreciated by those around her.

In 2021, Carolyn was instrumental in Milano receiving a \$4 million grant from the US government to repair their roads. Once she sees that project through, she plans to retire, where she'll spend her time gardening and helping her daughter's charity.

Annual Statements Going Green

Your 2022 Annual Statement will be posted in MyTMRS and mailed in March. In 2024, TMRS will "go green." Statements will only be sent electronically, unless you opt into receiving a paper statement.

- If you have a MyTMRS account and only want to receive a 2023 electronic statement, you do not need to do anything.
- If you would like to receive a paper statement and an electronic statement, you must update your Communication Preferences in your MyTMRS account at tmrs.com (see below).
- If you do not have a MyTMRS account, you will receive a paper statement.
