Governor Abbott Appoints Jim Parrish to TMRS Board of Trustees



On September 27, Governor Greg Abbott appointed Jim Parrish to the TMRS Board of Trustees. Mr. Parrish fills the vacancy that was created when Trustee Roy Rodriguez retired.

Jim Parrish is the Human Resources and Risk Management Director for the City of McKinney. He has more than 20 years of executive-level human resources experience serving four cities with 800 to 2,500 employees.

Before joining the City of McKinney, Parrish served as the Deputy City Manager in Plano, Texas, and in various roles at the cities of McKinney, Carrollton, and Amarillo in administrative oversight of human resources, risk management, finance, budget, treasury, information technology services, municipal court, procurement, utility billing, marketing and communication, project management, and media relations.

Mr. Parrish is former president of the Texas Municipal Human Resources Association and a former board member of the Texas Municipal League. He previously served as a gubernatorial appointee on the TMRS Board of Trustees for over eight years.

Parrish has a Bachelor of Business Administration and an MBA from West Texas A&M University.

In September, Mr. Rodriguez retired from the City of McAllen, where he was the City Manager and a member of the Texas City Managers Association (TCMA) and Region 10 president. He is a member of the American Society of Civil Engineers, Rio Grande Drainage Committee, Rio Grande Valley Metropolitan Planning Organization, and South Texas College Public Administration Advisory Council. He is a former director of the Lower Rio Grande Water Committee and former gubernatorial appointee to the TMRS Board of Trustees, where he twice held the position of chairman between 2005 and 2018. Additionally, he serves in multiple roles for Our Lady of Perpetual Help Catholic Church.

Since retiring, Mr. Rodriguez has been hired as a consultant for Hidalgo County focusing on planning and economic development.

Rodriguez received a Bachelor of Science in Civil Engineering from Texas A&M – Kingsville and Master of Public Administration from The University of Texas Rio Grande Valley.
