2022 Annual Comprehensive Financial Report is Available

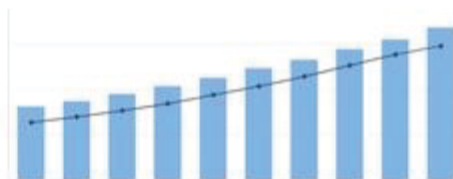
