Your Account Information

2022 1099-R Forms

TMRS mails form 1099-R each year before January 31. You can also view and print form 1099-R using MyTMRS. Check tmrs.com in early 2023 for updates.

HELPS

If you are a retired public safety officer and enrolled in the HELPS program, TMRS will contact you in January stating your 2022 insurance premium payments. You can update your premium amount using MyTMRS.

Keep Your Beneficiary Up to Date

Life changes such as birth, marriage, and death may make it necessary for you to update your beneficiary. Keeping your beneficiary designations up to date ensures your benefits are paid according to your wishes. You can update beneficiaries using MyTMRS at tmrs.com.

Marital Changes After Retirement

If you marry after retirement, you can change your Retiree Life Only or Guaranteed Term option to a Survivor Lifetime option that provides a monthly death benefit to your new spouse. Or, if you retired under a Survivor Lifetime option and your original beneficiary dies and you remarry, you can make this change. You may also be eligible to change your retirement option if you divorce after retirement. You have one year after the date of your marriage to your new spouse to change your retirement option.

Important To Know:

- You must contact TMRS at 800.924.8677 to change your retirement option.
- Changes to your retirement option can only be done in qualifying circumstances.
- This change can only be made once and cannot be done through MyTMRS.




Annual Statements Going Green

Your 2023 Retirement Benefit Statement will be posted in MyTMRS and mailed in February. In 2024, TMRS will "go green." Statements will only be sent electronically, unless you opt into receiving a paper statement.

- If you have a MyTMRS account and only want to receive a 2024 electronic statement, you do not need to do anything.
- If you would like to receive a paper statement and an electronic statement, you must update your Communication Preferences in your MyTMRS account at tmrs.com (see below).
- If you do not have a MyTMRS account, you will receive a paper statement.
